

What is planned giving?

A planned gift is any major gift, made in lifetime or at death as part of a donor's overall financial and/or estate planning. These include gifts of equity, life insurance, real estate, personal property, or cash.

Who can give?

Anyone of any age can designate a gift in various forms and all sizes at any time.

Why give?

Planned giving allows donors to include Youth Education in the Arts in their will designating a gift (called a "bequest") to the organization. Planned giving requires no present obligation, but instead allows donors to look to the future of the organization as part of their estate plan.

What's involved?

Donors may make a general, unrestricted gift that will be available for Youth Education in the Arts to use in any capacity. Donors also have the option to make a restricted gift to be used in a manner designated by the donor. This allows a donor to make a lasting impact in a way that is meaningful for them and for the young people served by Youth Education in the Arts programs: The Cadets, USBands and Xcape.

What are the benefits?

You leave a lasting legacy to be remembered; You may lessen the burden of taxes on your family; You may receive estate tax savings; You help to ensure the future mission of the organization.

I want to give. What do I do now?

A bequest is one of the easiest gifts to make. With the help of a financial and/or legal advisor, you can include language in your will or trust specifying a gift be made to family, friends or Youth Education in the Arts as part of your estate plan.

A bequest can be made in several ways:

- > You can gift a specific dollar amount or asset;
- > You can gift a percentage of your estate;
- > You can gift from the balance or residue of your estate;
- > You can make a beneficiary designation of certain assets.

Can I specify how Youth Education in the Arts uses my bequest?

You have several options for declaring how we may use your bequest once we receive it. They are:

An unrestricted bequest – This is a most useful gift as it can be leveraged to the best possible use at the time we receive it.

A restricted bequest – This is a gift for a specific use, such as a special project or program that is important to carrying out your wishes.

An endowed bequest – This is a restricted or unrestricted gift where our organization invests your donation to start an endowment to be distributed in accordance with an endowment spending policy.

An honorary bequest – This is a gift made in honor of someone else's memory to recognize their passion for the organization.

I don't have a will. How else can I give?

Here are a few other simple ways for you to make a bequest to us simply by making Youth Education in the Arts a beneficiary for one or more of the following: life insurance policy, IRA, 401k, or other retirement plan; savings bonds; bank accounts and securities.

What is the correct legal name to use for my gift?

All legacy gifts should be directed to "Youth Education in the Arts." Please also indicate whether the gift is for general purposes or for a particular program or purpose.

What is the Tax ID Number I should use for my gift?
